

Reference Letter for Jessica Wells

Jessica Wells is a top-notch young lady. In our search to find someone to teach both vocal and instrumental music we had the honor to consider many quality candidates. Jessica was a great 'fit' for the middle school and was selected to join our education team. Jessica has invested herself in our school environment and is respected by students, parents, and our staff. Jessica works with her team of choral -3 and instrumental -4 staff members as they coordinated district choral concert hosting elementary, middle, and high school choirs.

Jessica took on the unique choir/instrumental music position knowing that we were going to implement a few new things this school year. One of which was the inclusion of 6th grade band in the school day. Jessica's patience and tenacity supported her through the trials and tribulations of this implementation.
